Clean-Up Day

The town will be organizing a community clean-up day, the event will include incentives and fun activities. We take pride in maintaining a beautiful clean community and encourage community volunteers and organizations to join our staff and beautification committee in maintaining a cleaner & greener community.

Councillor Aylward

Provided an update on West Coast Healthcare Action Committee meeting with Western Health last week. Currently there is a technologist position advertised for Mammograms. She acknowledged our hospital is receiving some support for shared services for surgeries, and there was communication of extra ER doctors and a nurse practitioner hired. However, our hospital still does not have an anesthesiologist, she noted the STRH is a pain management site for the region. She assured the public that STRH will not be affected with the opening of the new hospital in Corner Brook.

Deputy Mayor Fowlow referenced a government program whereby medical professionals visit sites to complete surgeries, for example St. Anthony. Councillor Aylward stated Western will not agree to having this service here. Councillor O'Brien stated the workload and demands for mammograms will only increase as they lowered the screening age from 50 years old to 40 years. Councillor Hynes praised Councillors Aylward as the town's representative and advocate for healthcare.
