Councillor Roberts

Inquired on the status of Main Street reconstruction. The Planning & Development Manager stated the project is scheduled to begin in August 2024 with estimated completion time of 6-8 weeks.

Mayor Rose

Stephenville Synergy Symposium

He acknowledged the impeccable job of management and staff who put together first Stephenville Synergy Symposium event that was held at the Royal Canadian Legion. The event brought together stakeholders and community participants for an engagement session. Keynote speakers included World Energy, Atlas Salt, Triple Point and Aramark along with BIA and Chamber of Commerse and myself. The groups provided an update; World Energy is moving forward with the final investment decision expected in the first quarter of 2025. Atlas Salt provided their business model which included green mining operations to deliver road salt to North American Market. Triple Point is unique with domes that has highly compressed salt that will have the ability to store hydrogen, And Aramark is a fortune 500 company with 270,000 employees who may be bidding on the work camps. There were 120 registered for the event and this may become an annual event. The CAO gave recognition to Deputy CAO, Communication Coordinator, and all other staff involved that executed a successful event on short notice. Deputy Mayor Fowlow suggested also hold a Human Service Symposium as it could provide a valuable discussion

of the impacts of economic growth on social factors. Councillor Aylward and Councillor White both stated the event was successful.

June 21, 2024

The Town will have official ceremony to unveil two structures that will be erected in the towns new cultural space at 5:00pm behind Zion Pentecostal Church (old soccer field). We had support from indigenous groups such as Newfoundland Womens Network, People of the Dawn, Qalipu, Empowering Indigenous Women, and Mi'Kmaw Cultural Centre.

Kin Square

He expressed discontent with BIA over Kin Square on Main not being utilized. The Town has money invested, and he suggested for the BIA to manage and utilize the space or alternatively permit the town to manage the property. He encouraged management to engage with the BIA (Business Improvement Association) to collaborate on a plan to utilize the area on Sundays starting July 1 to host local talent. In response Councillor O'Brien stated he had a discussion with the BIA as council's representative. He stated it's unfair to the BIA to publicly be negative towards the group. He stated the town did support the Kin Square project by providing a grant to purchase the property, however the town was not the biggest contributor. Additionally, the town did not provide the BIA with matching funds over six-year period which limited their ability to take further action.

Councillor Roberts and Deputy CAO left the chambers from 12:59pm and returned 1:00pm

Deputy Mayor Fowlow recognized current town staff constraints are limited to execute event planning at Kin Square.
